## **2023 TRAEGER DAY SWEEPSTAKES OFFICIAL RULES**

BY ENTERING THE SWEEPSTAKES AND SUBMITTING VIDEO AND/OR PHOTOGRAPH CONTENT ("CONTENT"), ENTRANT AGREES TO AND ACCEPTS THE 2023 TRAEGER DAY OFFICIAL RULES ("OFFICIAL RULES"), WHICH CONSTITUTE A LEGALLY BINDING CONTRACT BETWEEN ENTRANT AND TRAEGER PELLET GRILLS LLC ("TRAEGER").
